

Tips & Steps to Return to China for International Students

(revised on November 22, 2022)

Foreigners who comply with China's entry regulations must strictly abide by China's regulations on epidemic prevention and control. China has some of the world's most stringent quarantine regulations and safety protocols, with lots of isolation rules to follow. For many travelers, this can be quite confusing at first. That's why we've put together the related information you need for your trip – from preparation to arrival and from quarantine to completion.

The tips & steps include, but are not limited to the following:

1	<ul style="list-style-type: none"> ● Submit Resumption Application & Letter of Commitment (attachment 1, 2) ● Examine and approve by FIS 	<p>Email the attachments (1,2) to jjufis@126.com and title with: batch+year+name+resumption application</p>
2	<ul style="list-style-type: none"> ● Letter of Consent be issued by FIS ● Confirm with the Information Form (attachment 3) 	<ul style="list-style-type: none"> ● Check your Email and get the Letter of Consent issued by FIS in 1-2 days ● Send confirmation and Information Form to jjufis@126.com and title with: batch+year+name+confirmation
3	<p>Before You Fly: Preparation for China Quarantine Rules</p>	<ul style="list-style-type: none"> ● Within 48 hours before departure, take one nucleic acid test at the acknowledged test reagent. ● You'll also need flight itinerary, your entry visa or residence permit, Letter of Consent and an official health declaration QR code, which must be registered and filled in before you fly. You can access this, and make all the necessary preparations for China quarantine rules, via the WeChat application. Passengers will receive a “green code” when all their test results are verified. Before boarding, passengers will be required to present “green code”. ● Notify Ms. Zhang after CHECKING IN at the airport
4	<p>When You Arrive: Entering China and Starting Quarantine</p>	<ul style="list-style-type: none"> ● Upon arrival in China, you will be screened at the airport. Your documents will be checked, and you will need to undergo another PCR test. ● Once you have passed this test, you will be transferred by the authorities to an official quarantine facility (Hotel) allocated by the government, quarantine for a minimum of eight (8) total days. ● Facilities can be quite basic in some places, with limited

		<p>amenities and movements severely restricted (in most cases, there will be an alarm on your door to stop you from leaving – if it sounds, you must restart your quarantine from the beginning).</p> <ul style="list-style-type: none"> ● Notify Ms. Zhang after CHECKING IN at the quarantine facility (Hotel), send the Hotel Name and Address, Email to jjufis@126.com and title with: batch+year+name+hotel name
5	<p>During quarantine: What to Expect and What to Prepare</p>	<ul style="list-style-type: none"> ● During and after this period, travelers will be able to undergo follow-up inspections. Additional quarantine periods, tests, or health monitoring may be required if you travel from a Chinese city of entry to another city or region. Additional restrictions may apply depending on the location you visit. ● To avoid boredom and stay healthy, it's a good idea to prepare some entertainment and exercise – bring books, films, games, craft projects and light workout equipment, to help you pass the time. ● Be present at the online class, do not be absent. ● The cost of quarantine is your responsibility, including hotel room rate, meals, and other personal expenses.
6	<p>After quarantine:</p> <ul style="list-style-type: none"> ● Travel from entry city to Jiujiang ● 7 days' home observation 	<p>After you have completed the initial quarantine period in a government-appointed facility, there are still some important isolation rules you will need to follow.</p> <ul style="list-style-type: none"> ● Scan or photo, send your quarantine status paper, nucleic acid nucleic acid tests result and 14 days previous travel information to email jjufis@126.com and get the approval from FIS of your travel from your city of entry to Jiujiang. ● After getting the approval from FIS, travel from quarantine facility (Hotel) to the airport or train station of your entry city. ● Arrive at Jiujiang Train Station or Nanchang Airport, notify Ms. Zhang. ● Call a Taxi from Jiujiang Train Station or Nanchang Airport to Jiujiang University, notify Ms. Zhang. ● Traveling to other cities or regions is extremely prohibited. ● 7 days' home observation at allocated school dormitory is compulsory. <p>Send your quarantine status paper, nucleic acid tests result and 14 days previous travel information, email to jjufis@126.com and title with: batch+year+name+quarantine result</p>

Notes:

1. Please be notified that purchasing the international ticket between January 1, 2023, and February 15, 2023, is not suitable since it is university winter vacation interval.
2. The new bedding will be purchased & prepared in advance by the dormitory manager, 330 Yuan RMB approximately, please get the money ready.
3. Your passport must be valid for 6 months beyond your stay in China.
